CONDITIONS OF EQUIPMENT HIRE

- "Equipment" means all Equipment including any accessories supplied on hire by Height Dynamics to the Client (and where the context so permits shall include any supply of Services). The Equipment shall be as described on the invoices, quotation, authority to hire, or any other work authorisation form provided by Height Dynamics to the Client.
- "Minimum Hire Period" means the Minimum Hire Period as described on the invoices, quotation, authority to hire, or any other forms as provided by Height Dynamics to the Client.
- The Equipment shall at all times remain the property of Height Dynamics and is returnable on demand by Height Dynamics. In the event that the Equipment is not returned to Height Dynamics in the condition in which it was delivered Height Dynamics retains the right to charge the Price of repair or replacement of the Equipment.
- The Client shall:
 - keep the Equipment in their own possession and control and shall not assign the benefit of the Equipment nor be entitled to lien over the Equipment.
 - not alter or make any additions to the Equipment including but without limitation altering, make any additions to, defacing or erasing any identifying mark, plate or number on or in the Equipment or in any other manner interfere with the Equipment.
 - keep the Equipment, complete with all parts and accessories, clean and in good order as delivered, and shall comply with any maintenance schedule as advised by Height Dynamics to the Client.
 - keep the Equipment at the address that has been agreed upon by Height Dynamics and shall not move the Equipment from this location unless prior written authorisation has been provided by Height Dynamics.
- The Client accepts full responsibility for the safekeeping of the Equipment and the Client agrees to insure, or self-insure, Height Dynamics's interest in the Equipment and agrees to indemnify Height Dynamics against physical loss or damage including, but not limited to, the perils of accident, fire, theft and burglary and all other usual risks and will affect adequate Public Liability Insurance covering any loss, damage or injury to property or persons arising out of the use of the Equipment. Further the Client will not use the Equipment nor permit it to be used in such a manner as would permit an insurer to decline any claim.
- Notwithstanding the above clauses, immediately on request by Height Dynamics the Client will pay:
 - any lost hire charges Height Dynamics would have otherwise been entitled to for the Equipment, under this, or any other hire agreement;
 - any insurance excess payable in relation to a claim made by either the Client or Height Dynamics in relation to any damage caused by, or to, the hire Equipment whilst the same is hired by the Client and irrespective of whether charged by the Client's insurers or Height Dynamics's.
- Return of the Equipment ("Return") will be completed when:
 - the Equipment is returned by the Client to Height Dynamics's place of business; or
 - when Height Dynamics takes back possession of the Equipment once collection by Height Dynamics is affected.

I accept the supply of Equipment, as detailed above, and certify that the information stated herein is true and correct.
